
About the Massachusetts Biotechnology Education Foundation (MassBioEd)

Secretary Acosta manages the Commonwealth's workforce development and labor departments to ensure that workers, employers, and the unemployed have the tools, training, and safety resources needed to succeed in the Massachusetts economy. Secretary Acosta also Chairs the Workforce Skills Cabinet alongside the Secretary of Education and the Secretary of Housing and

Economic Development. Prior to joining the Baker-Polito Administration, Secretary Acosta was a widely respected financial and banking service professional with over thirty years of experience in Greater Boston financial institutions. Secretary Acosta was a Director and Planning Committee Member of the Merrimack Valley Workforce Investment Board and was appointed a Northern Essex Community College Trustee by Governor Baker. Dr. F. Javier CevallosPresident, Framingham State University

Dr. Cevallos was born in Cuenca, Ecuador and his family moved to Puerto Rico when he was 14. Dr. Cevallos earned his bachelor's degree in 1976 at the University of Puerto Rico at Mayagüez. From Puerto Rico, he moved to Illinois where he earned his master's and doctoral degrees in 1978 and 1981, respectively, from the University of Illinois at Urbana-Champaign. His area of research is Latin American literature, with particular emphasis in the Colonial era. He began his career in education

in 1981 as an assistant professor of Spanish at the University of Maine at Orono. In 1984, he moved to the University of Massachusetts at Amherst, where he was promoted to associate professor in 1988 and to full professor in 1992. In 1994, he was asked to serve as faculty advisor to the provost. In 1996 he was selected as a Fellow by the American Council on Education (ACE) and spent his fellowship at Wesleyan University, in Middletown, Connecticut. Upon his return to UMass, Cevallos became chair of the Department of Spanish and Portuguese. Soon after, he was appointed Vice Chancellor for Student Affairs, a post he held until 2002, when he became President of Kutztown University in Pennsylvania for many years, until beginning his tenure as President of Framingham State University in 2014.

Gretchen Cook-Anderson is an award-winning marketing/communications executive with over 28 years promoting the sciences, global education, political candidates and major household products. In her current role, she leads efforts at the first-and-only-of-its-kind platform that's addressing systemic racial, gender and other underrepresentation in talent across the life sciences and the biotech industry – from labs to leadership, and from the STEM student pipeline to the

entrepreneurs advancing life-changing innovations. Ignite was launched in early 2021 by LabCentral, a preeminent early-stage biotech startup accelerator, as a forward-thinking, equity-driven way to support the workforce needs of the industry. Gretchen was honored in October 2020 among the inaugural 50 Most Influential Businesspersons of Color by the Newton-Needham Chamber of Commerce (MetroWest region). She was also recognized in February 2021 by the Massachusetts Legislature as a Black Excellence on The Hill honoree. Vice President of Mission and Associate Chief Medical Officer, Boston Medical Center (BMC), Director of BMC Violence Intervention Advocacy Program and Associate Professor of Emergency Medicine at Boston University School of Medicine

Dr. James has primary responsibility for coordinating and maximizing BMC's relationships and strategic alliances with local, state, and national organizations to foster innovative and effective models of care that are essential for patients and communities to thrive. Integrating upstream

interventions into BMC's clinical care models are critical in achieving equity and health. Dr. James served on the Massachusetts Board of Registration in Medicine 2009-2012 as chair of the Licensing Committee. As the Supervising Medical Officer on the Boston Disaster Medical Assistance Team under the Department of Health and Human Services, Dr. James has deployed to New York City post 9/11; New Orleans after Hurricane Katrina in 2005; Bam, Iran after the 2003 earthquake; and Port-Au-Prince, Haiti after the 2010 earthquake. She is a member of the Board of Directors of Equal Health, an organization that supports sustainable medical and nursing education systems in Haiti. She was awarded the Boston Public Health Commission's 2008 Mulligan Award for public service; the Suffolk County District Attorney's 2012 Role Model Award, and the Schwartz Center 2014 Compassionate Care Award. She received The Boston Business Journal Healthcare Hero Award in 2012 and 2015. The Boston Chamber of Commerce awarded Dr. James the Pinnacle Award in 2015 and she was a 2019 Massachusetts Public Health Association Health Equity Champion. In 2020, Dr. James received the American College of Emergency Medicine Lifetime Achievement Award; a History Maker Award from The History Project; and the inaugural Thea James Social Emergency Medicine Award from the American College of Emergency Physicians. A graduate of Georgetown University School of Medicine, Dr. James trained in Emergency Medicine at Boston City Hospital, where she was a chief resident.



Renée M. Landers, J.D.

Professor of Law, Suffolk University Law School, and Faculty Director, Health and Biomedical Law Concentration and the Master of Science in Law Life Sciences program

Renée M. Landers was a Distinguished Visiting Fellow at the National Academy of Social Insurance during her fall 2018 sabbatical leave. President of the Boston Bar Association in 2003-2004, she was the first woman of color and the first law professor to serve in that position. She has worked in private practice and served as Deputy General Counsel for the U.S. Department of Health and

Human Services and as Deputy Assistant Attorney General in the Office of Policy Development at the U.S. Department of Justice during the Clinton Administration. Currently, she is co-chair of the Section's Diversity Committee and is a member of the group that created the Section's fellowship program to help nontraditional candidates enter legal academia. In June 2020, she was elected chair of the board of Planned Parenthood League of Massachusetts. An elected member of the National Academy of Social Insurance since 2008, she is President of the NASI Board of

Directors. Landers was a member of NASI's study panels on Strengthening Medicare's Role in Reducing Racial and Ethnic Health Disparities and on Health Insurance Exchanges and Changing the Medicare Eligibility Age, and currently is co-chair of the Study Panel on Economic Security. Professor Landers has served as the president of the boards of Big Sister Association of Greater Boston, the Shady Hill School, the Harvard Board of Overseers, and has also served on the board of WGBH and the Board of Overseers of Geisel School of Medicine at Dartmouth. She was named among the "2020 Top Women of Law" by Massachusetts Lawyers Weekly. In November 2018 she was elected a Fellow of the ABA Section of Administrative Law and Regulatory Practice and was named a Senior Fellow of the Section in 2021, the Section's highest recognition.

Associate Professor, School of Public Policy & Urban Affairs and Department of Economics; Research Director, Dukakis Center for Urban and Regional Policy, Northeastern University

Alicia Sasser Modestino is also a Research Fellow at the Harvard Kennedy School's Woman and Public Policy Program, a Nonresident Fellow at the Brookings Institution's Metropolitan Policy Program, and an Affiliated Researcher of the Abdul Latif Jameel Poverty Action Lab (J-PAL) at MIT.

Previously, Dr. Modestino was a Senior Economist at the Federal Reserve Bank of Boston where she led numerous research projects on regional economic and policy issues for over a decade. Dr. Modestino's current research focuses on labor and health economics including youth development, changing employer skill requirements, childcare, and the opioid crisis. Much of her research is interdisciplinary and involves large-scale empirical evaluations to determine underlying causal relationships using a variety of data, methods, and techniques. She has amassed over \$8 million in external funding, including grants from the Arnold Foundation, J-PAL, the National Science Foundation, the Russell Sage Foundation, the Spencer Foundation, the Social Innovation Fund, and the William T. Grant Foundation. Her work has been published in peer-reviewed publications and her research has been covered extensively in the media. Dr. Modestino holds both a Master's degree and a Ph.D. in Economics from Harvard University, where she also served as a doctoral fellow in the Inequality and Social Policy Program at the Kennedy School of Government.

Before entering the field of education, she was a researcher in astrophysics at the Harvard-Smithsonian Center for

Astrophysics, in Cambridge, Massachusetts, and the Max Planck Institut für Astronomie, in Heidelberg, Germany. She then joined the Massachusetts Institute of Technology where she became the Director of the Education and Outreach Group of the MIT Kavli Institute for Astrophysics and Space Research. 
